

MEMORANDUM OF UNDERSTANDING
(MOU)

BETWEEN

Metro Nursing Home, Jhansi

Represented by the Chief Administrator

AND

Sharda Devi Degree College, Jhansi

Represented by the President

This **MOU** made on the **20th day of DECEMBER 2020**, between **SHARDA DEVI DEGREE COLLEGE, JHANSI** having its office at Rajgarh, Jhansi, Uttar Pradesh - 284135 --- (hereinafter referred to as 'SDDC Jhansi') through its authorised signatory and **METRO NURSING HOME, JHANSI**. a private trust/society duly registered with _____ having its office at Jhansi - Lalitpur Road, Hansari Jhansi, Uttar Pradesh - 284003 (hereinafter referred to as 'MNH').

WHEREAS **SDDC** Jhansi is an educational body engaged in education and interested to avail medical treatment facility for its Faculty, Students and Staff.

and WHEREAS **MNH** is a multi specialty, trust managed hospital providing medical facilities in all the fields and specialties and agrees to provide medical facilities to the employees, their families and students of SDDC Jhansi.

Now this MOU witness and it is agreed by and between the parties as follows:

- 1) A written request for hospitalisation (i.e. IPD) should be made by SDDC Jhansi. This request will be either faxed / e-mailed or hand delivered by the beneficiary and produced at the time of admission along with photo identity proof issued from SDDC Jhansi. MNH will not provide a credit facility without this letter. In an emergency, the patient should be treated as per the hospital norms. However the request letter will be submitted latest by next working day.
- 2) MNH shall provide cashless facility to the staff and their families (as defined under SDDC rules) only for IPD operations. This facility will not be available to the students except under emergency situations. Reimbursement to the staff will be as per SDDC Medical policy.
- 3) MNH will not provide cashless facilities for Medicine, X-Ray and other. The patient will claim for the same from SDDC, after discharge.

4) SDDC Jhansi will not be responsible for making payments for items such as special attendant charges, telephone, snacks, food and beverages etc. and must be directly collected from the beneficiary.

5) After the beneficiary is discharged from the Hospital, MNH shall submit the bill along with supporting documents to SDDC Jhansi for reimbursement.

6) Payments in respect of the Final Bills shall be made by SDDC Jhansi directly to MNH within a period of 25 days from the date of receipt of the Final Bill.

7) MNH shall furnish to SDDC Jhansi the Detailed Schedule of Charges for various services and will keep informed about any revision in the charges, which may take place from time to time.

8) The SDDC Jhansi beneficiary will be provided best possible treatment by the panel of consultants attached to MNH according to the practice parameters and clinical protocols established by MNH.

9) In the event of termination of the MOU, SDDC Jhansi will be responsible for payment of bills of its authorised beneficiaries admitted prior to the date of termination of this MOU.

10) MOU can be terminated by either party by giving one month's prior notice.

11) Any disputes, claims arising out of this Agreement are subject to arbitration and subject to the jurisdiction of JHANSI courts only.




